





# NATIONAL SKILLS QUALIFICATION FRAMEWORK (NSQF)

The National Skills Qualification Framework (NSQF) is a nationally integrated education and competency-based skill quality assurance framework developed by the National Council of Vocational Education and Training (NCVET) to organize qualifications according to a series of levels of knowledge, skills and aptitude. NCVET has been set up as an overarching umbrella regulator establishing regulations and standards to ensure quality in the Technical Vocational Education and Training (TVET) space.



There are ten NSQF levels which are defined in terms of learning outcomes which the learner must possess regardless of whether they were acquired through formal, non-formal or informal learning.

It enables a person to acquire desired competency levels, transit to the job market and, at an opportune time, return for acquiring additional skills to further upgrade their competencies.


#### The key elements of the NSQF provide:

- National principles for recognizing skill proficiency and competencies at different levels leading to international equivalency
- Multiple entry and exit between vocational education, skill training, general education, technical education and job markets
- Progression pathways defined within skill gualification framework
- Opportunities to promote lifelong learning and skill development
- Partnership with industry/ employers
- Increased potential for recognition of prior learning

# **NATIONAL OCCUPATIONAL STANDARDS (NOS)**

The National Occupational Standards (NOS) specify the standard of performance an individual must achieve when carrying out a function in the workplace, together with the knowledge and understanding they need to meet a standard consistently.

Each NOS defines one key function in a job role. Each NOS must be concise and describe the functions, standards of performance and knowledge/understanding.




#### Qualification Packs (QP)

A Qualification Pack (QP) is a set of NOS aligned to a job role. A QP for every job role in each sector drive both the creation of curriculum and assessments. Thus, the National Skills Qualification Framework (NSQF) theoretically makes it possible to drive competency-based training for every job role in the industry.


### SKINCARE

# HAIR DRESSING




# COSMETOLOGY






# MAKEUP
