Eligibility Criteria for Candidates

- Candidates who are willing for wage employment on completion of training shall be enrolled.
- ➤ Candidates enrolled must possess the qualification as prescribed by the Sector Skill Council as per respective Job role QP.
- ➤ Before enrolling, Trainee(s) must give in writing his/her willingness for wage employment along with details of point of contact/Guardian and their consent letter.

Eligibility Criteria for Training Partners

- > Training Partners having prior experience of at-least 3 years in running state funded training programs in India (preference shall be given to training partners with experience in South India)
- > Training partners with placement record of at least 70% in government funded training programs.
- Training partners having annual turnover more than 2 crores in last financial year and average turnover of 1.5 crores in last 3 financial years.
- Training partners having at-least 4 ToT certified trainers from SSC.

Objective and Outcome of the Program

- ➤ Wage Employment with an employer of repute to at least 70% candidates.
- Self-employment support to the candidates.

Payment:

Payment shall happen as per the approved latest common cost norms for training, for CCN Category 2. In below tranches:

30%: On commencement of training (on submission of documents)

30% : On 70% attendance. 20%: : On Certification

20%: On placement 20% fee will be paid on pro-rata basis for self-employment support to candidates.

TP shall be eligible for 100% payment if unit /individual enterprise takes place with minimum 70% of the certified batch.
