1.	Has the organization registered and has valid GST/ PAN No.?	Certificate of incorporation letter, GST Letter/ PAN Card to be attached
2.	Whether the organization has had a positive net worth?	Audited account statement for last 3 years

3.	Weather the Training Partner has Accredited centre or Not ?	Accreditation certificate of minimum 2 accredited TC on Skill India Portal
4.	Whether the Training Partner has Trained or is Currently Training More than 1,000 Candidates under in the Last 2 Years.	Details of candidates to be provided as per Annexure- A
5.	Whether the Training Partner has Industry Tie-ups?	Valid Lol / tie up letter for placement in STT and Industry declaration for RPL
6.	Whether the Training Partner has TOT certified Trainers	TOT Certificates of minimum 5 trainer certified/ nominated trainers before 20th June 2024
7.	Whether the Training Partner has worked with minimum 3 sector skill councils/Govt Department in any State scheme?	Copy of Work Order/ Sanction letter/ work allocation issued by any SSC/govt department.

Note: Training partner working in Maharashtra state will be given preference in this EOI.
