## **Eligibility Criteria for Training Partners**

- Training Partners must have at least 10 years of experience in the field of skill development.
- Training Partners must be a SEBI-listed entity and NSDC partner.
- The Training Partner should have a minimum placement record of 70% in government-funded training programs.
- Training Partners must have an annual turnover of over ₹3 crores.

**Objectives and Expected Outcomes of the Program**

- Wage Employment: At least 70% of candidates should secure wage employment with reputed employers.
- Self-Employment Support: Candidates opting for self-employment will receive financial support for setting up their businesses.

**Payment Structure**

Payments will be made in accordance with the latest Common Cost Norms for training, boarding, and lodging, as approved by the Ministry of Skill Development & Entrepreneurship (MSDE) and Tripura Skill Development Mission
