


Fig 1.1.1 : Depicting Workforce Requirement in Aesthetic Skin Services Across Years, 2022-2030




Fig 1.1.2 : Occupational Map of an Aesthetic Skin Technician

1.2.1 Synopsis of Beauty and Wellness Sector

Globally the Beauty and Wellness sector is considered as a sunrise industry. The beauty and wellness sector in India is experiencing a significant growth trajectory, driven by evolving consumer preferences, increasing disposable incomes, and expanding urban middle class. This sector encompasses a wide range of products and services, including skincare, haircare, cosmetics, spa treatments, fitness, and holistic wellness practices. With the rise of social media influencers and digital platforms, there's been a surge in demand for beauty products and services, particularly among the youth demographic. Additionally, strong consumption along with an overall shift and focus on healthier lifestyle choices, especially post pandemic, shows immense potential for the industry to boom in near future.

The global Beauty and Wellness Industry grew at about 17.6 percent between 2017 and 2022 to reach USD 4,500 billion (INR 380 lakh crore) from about USD 2,000 billion (INR 150 lakh crore) in 2017. For a young country like India, with 700+ million individuals below 25 years of age, the Beauty and wellness sector of the country has a huge potential to generate livelihoods in metros as well as in small towns without promoting mass-scale migration to large metros.


1.2.2 Key Sub-Sectors within the Indian Beauty and Wellness Industry

The beauty and wellness sector in India encompasses various subsectors that cater to personal care, grooming, and overall well-being. Some of the prominent subsectors include:

 Beauty and Salon: The beauty and salon industry comprises more than 30 per cent of the overall Beauty and Wellness sector of the country and is anticipated to grow to close to INR 80,000 crore market by 2025. The industry is growing at an impressive rate of 17 per cent annually and is expected to develop twice as quickly as the US and the European markets in the next few years.

The key segments within the Beauty and Salon sub-sector includes professional skin & body care and Hair & personal care (professional hair care, professional oral care and professional shower and bath care).

- 2. Aesthetic Skin Services: The aesthetic skin services sector in India has seen significant growth driven by macroeconomic factors and aspirations for body perfection. Expected to reach INR 68,000 crore by 2024, with a per capita spending rise from INR 375 in 2018 to INR 480. In 2020, surgical procedures totalled 255,528, with liposuction being the most demanded at 23.5%, followed by rhinoplasty and breast augmentation. Nonsurgical procedures in 2020 were around 268,536, with hair removal dominating at 36.5%, followed by chemical peels at 16.7%. Non-invasive cosmetology, a key component, contributes around INR 10,000 crore, growing at a double-digit rate. Driven by social media influence and increasing beauty consciousness among various age groups, India ranks in the top ten for non-surgical cosmetic procedures as of 2020.
- 3. Alternate therapies: The alternate therapies industry of the country has observed a steep rise of 15.4 per cent in patient uptake for AYUSH treatments, largely on account of increased awareness of costeffective methods and treatments, and fewer potential side effects. The industry is anticipated to grow at close to double digit growth rate annually to achieve an INR 30,000 crore market by 2024. Services may broadly involve Acupuncture, Chiropractic, Naturopathy, Neurotherapy, Aromatherapy, Homeopathy, Oriental treatments, and therapies focusing on Relaxation and Stress management.






Fig 1.2.1 : Key Sub-Sectors and Growth of Beauty and Wellness Industry in the Country, 2017-2022

4. Nutraceuticals: The nutraceuticals sector in India encompasses functional food (25%), beverages (15%), and health supplements (60%), offering additional health benefits. Anticipated to grow at 20% between 2017 and 2024, aiming for a market share of INR 100,000 crore by 2024, including spillovers to related sectors. Primarily urban-centric, driven by increased income and health-consciousness. Expected to hold about three per cent of the global market share by 2022, up from two per cent in 2020.

5. Rejuvenation: The Spa and Rejuvenation industry in India is rapidly expanding, fuelled by Wellness Tourism and increasing awareness of well-being. Despite comprising only five per cent of the broader Beauty and Wellness sector, it's one of the fastest-growing subsectors. Expected to reach INR 12,750 crore by 2024 from INR 4,200 crore in 2018, growing over 20% annually, with a rising demand for skilled technicians. In 2022, the sector needed 145,000 professionals, with 45% demand from organized sectors. India ranked fifth in Photo Rejuvenation procedures in 2020, showing potential for further growth, especially considering the dominance of the USA in the market.

6. Weight Management: The sub-sector's growth is fuelled by a heightened focus on personal health and well-being, with nearly one in every four individuals overweight in 2019, compared to one in every five in 2015-16. Services like Zumba, Pilates, and Aerobics are gaining traction, with an anticipated 11% annual growth from 2022 to 2027, driven by urban Indians' increasing health awareness and social media influence.

7. Yoga: Interest in Yoga is surging, evident from a 37.4% increase in foreign tourists visiting India for Yoga in 2018 compared to 2014. With the rise of COVID and lifestyle-related disorders, Yoga's therapeutic benefits are gaining global recognition. In India, 1,568 lakh people participated in International Day of Yoga (IDY) 2021, with a total outreach of 4,961 lakh. Globally, the industry is expected to grow at 9.6%, with online Yoga courses growing at 12.3% between 2021 and 2027.

8. The Products Manufacturing and Counter/Online - Sale of Beauty Products: This industry is poised to reach INR 125,501 crore by 2025, growing at a CAGR of 17% since 2018. This growth is driven by the rising preference for innovative, organic, and herbal products, along with increasing women's participation in the corporate world. Per capita spending is expected to rise to INR 380 by 2025. Factors contributing to this growth include growing disposable income, the emergence of online retail, and the youth's increasing interest in skincare and grooming. The sector includes body care, hair care, color cosmetics, men's grooming, fragrances, and more.
