Eligibility Criteria for Training Partners

- Training Partner must have at least 10 years of experience in the field of skill development.
- Training Partner must be a NSDC partner.
- Training Partner must have an annual turnover of over ₹3 crores.
- Training Partner must have experience of implementing skill development programs in the state of Tripura

Payment Structure

Payments shall be made on successful completion of training and assessment as per the cost approved by TRLM in accordance with the PMKVY guidelines and as approved by the Ministry of Skill Development & Entrepreneurship (MSDE) and Tripura Skill Development Mission.

Payments shall be disbursed on achieving the milestones as per the project requirement and upon submitting the valid proofs for same.
